MEMORANDUM OF LEASE AGREEMENT

Memorandum of Lease Agreement effective as of September 10, 2010 by TLP Rail Trust I, a Delaware statutory trust, as lessor (the "Lessor") and Trinity Industries Leasing Company, a Delaware corporation ("TILC") as manager and agent for the Lessor (in such capacity the "Manager").

W I T N E S S E T H:

The Manager, acting for the Lessor as its duly authorized agent, has executed Rider One (1) to Railroad Car Lease Agreement, effective September 10, 2010 (the "Rider"), pursuant to which the Lessor has agreed to lease to Preferred Sands of Genoa, L.L.C. (the "Lessee"), and the Lessee has agreed to lease from the Lessor, certain railroad cars bearing road numbers as listed on Exhibit A hereto.


