This Notice of Lease Termination effective as of April 6, 2009 by TLP Rail Trust I, a Delaware statutory trust (the "Lessor").

Lessor and World Energy Alternatives, LLC, a Delaware limited liability company (the "Lessee") are parties to that certain Railroad Car Lease Agreement, dated as of January 25, 2006, whereby Lessor agreed to lease to the Lessee and the Lessee agreed to lease from Lessor certain railroad cars pursuant to Rider Three (3) to Railroad Car Lease Agreement, effective September 8, 2006 (the "Lease Agreement").

The Memorandum of Lease Agreement was filed with the Surface Transportation Board on September 28, 2007 at 11:30 a.m. under Recordation Number 27181, as assigned to Lessor by that certain Memorandum of Assignment and Assumption Agreement which was filed with the Surface Transportation Board on September 28, 2007 at 11:30 a.m. under Recordation Number 27181-A.


