This Notice of Lease Termination effective as of April 1, 2009 by TLP Rail Trust I, a Delaware statutory trust (the "Lessor").

W I T N E S S E T H:

Lessor and Provista Renewable Fuels Marketing, LLC (f/k/a United Bio Energy Fuels, LLC), a Kansas limited liability company (the "Lessee") are parties to that certain Railroad Car Lease Agreement, dated as of June 8, 2006, whereby Lessor agreed to lease to the Lessee and the Lessee agreed to lease from Lessor certain railroad cars pursuant to Rider One (1) to Railroad Car Lease Agreement, effective June 8, 2006, as amended (the "Lease Agreement").

The Memorandum of Lease Agreement was filed with the Surface Transportation Board on October 19, 2006 at 1:33 p.m. under Recordation Number 26631, as amended by Amendment No. 1 to Railroad Car Lease Agreement, Rider One (1) which was filed with the Surface Transportation Board on October 31, 2006 at 12:15 p.m. under Recordation Number 26631-B, as assigned to Lessor by that certain Memorandum of Assignment and Assumption Agreement which was filed with the Surface Transportation Board on October 19, 2006 at 1:36 p.m. under Recordation Number 26631-A.

Notice is hereby given that the Lease Agreement is terminated with respect to the railroad cars listed on Exhibit A hereto.


This Notice of Lease Termination shall not impair nor terminate any of the rights and obligations of the parties under the Lease Agreement which, by their terms, expressly survive its termination.
