## PARTIAL RELEASE

SURFACE TRANSPORTATION BOARD

This Release is effective as of April 29, 2011 and filed by The David J. Joseph Company, a Delaware corporation ("Joseph") as owner of the Railcars (as defined herein).

WHEREAS, Joseph leased a group of railcars identified on Exhibit A hereto (the "Railcars") to Union Pacific Railroad through a Railroad Equipment Lease Agreement (the "Agreement");

WHEREAS, Joseph and Union Pacific Railroad memorialized the Agreement of record by filing a Memorandum of Railroad Equipment Lease Agreement and Memorandum of Amendment No. 1 to Railroad Equipment Lease (collectively, the "Memorandum of Lease") with the Surface Transportation Board (the "STB"); and

WHEREAS, the Memorandum of Lease was recorded with the STB and assigned recordation numbers 19449-A and 19449-C; and

WHEREAS, there has been a partial return of Railcars from Union Pacific Railroad to Joseph, and by such act, all interest of Union Pacific Railroad, its successors and assigns, in the Railcars arising pursuant to the Agreement has been terminated on the equipment bearing reporting marks attached in Exhibit B attached hereto ("Returned Equipment").

NOW THEREFORE, in consideration of the premises and mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt of which is hereby acknowledged, the parties agree as follows:

1. Union Pacific Railroad has returned the Returned Equipment to Joseph.
2. All interest of Union Pacific Railroad, its successors and assigns, in the Returned Equipment arising pursuant to the Agreement has been terminated.
3. Joseph hereby releases any lien created by or arising out of the Agreement with regard to the Returned Equipment.
4. This Release shall be recorded with the Surface Transportation Board under Recordation No. 19449-L so as to record the partial release of the lien against the Returned Equipment constituted by the Agreement bearing reporting marks specified in Exhibit B attached hereto.
5. This Release may be executed in as many counterparts as shall be determined by the parties hereto when so executed, each such counterpart shall be binding on both parties hereto, notwithstanding that both parties are not signatories to the same counterpart.
