PARTIAL TERMINATION OF SECURITY INTEREST SURFACE TRANSPORTATION BOARD


The undersigned, WILMINGTON TRUST COMPANY, not in its individual capacity but solely as Security Trustee (the "Security Trustee") under the Security Agreement - Trust Deed, dated as of April 29, 1993, for good and valuable consideration, the receipt and sufficiency of which are acknowledged, does hereby terminate, release and discharge a security interest held by the Security Trustee insofar as the same encumbers that certain railroad equipment identified as follows: one hundred and forty-three (143) aluminum body, bottom dump hopper cars bearing MPSX reporting marks and road numbers as more particularly described on Exhibit A attached hereto.

Such security interest was granted pursuant to that certain Security Agreement-Trust Deed, dated as of April 29, 1993 between Shawmut Bank Connecticut, National Association, not individually but solely as Owner Trustee under the Trust Agreement dated as of April 29, 1993 for the benefit of Norwest Bank Minnesota, National Association and Wilmington Trust Company, as Security Trustee, which was recorded with the Interstate Commerce Commission (predecessor to the Surface Transportation Board) on April 29, 1993 at 12 40 p m under Recordation Number 18217-A
