AS TO 255 SPECIALTY COVERED HOPPER CARS AND
65 PRESSURE TANK CARS

The undersigned, U.S. BANK NATIONAL ASSOCIATION (successor in interest through mesne assignments to STATE STREET BANK and TRUST COMPANY OF CONNETICUT, NATIONAL ASSOCIATION, a national banking association, not personally but in its capacity as Owner Trustee and Lessor, publishes this notice that Lease Supplement No. 1, dated as of September 27, 1999, (the "Lease Supplement No. 1") between the Lessor and BP Amoco Chemical Company, a Delaware corporation, as Lessee, with respect only to the 255 Specialty Covered Hopper Cars and the 65 Pressure Pressure Tank Cars identified on **Exhibit A** hereto (collectively the "Equipment") has expired in accordance with the terms of Lease Supplement No. 1 and has been partially terminated.

The Lessor hereby acknowledges (a) that all obligations of the Lessee under Lease Supplement No. 1 with respect to the Equipment have been duly performed and satisfied and that there remain no further obligations on the part of the Lessee under Lease Supplement No. 1 with respect to the Equipment except those terms of Lease Supplement No. 1 and the documents related thereto that by their express terms survive termination and (b) with respect to the Equipment the release of all liens and security interests, if any, created by the below referenced filings with the United States Surface Transportation Board.

Lease Supplement No. 1 was duly filed with the Surface Transportation Board on the date and under the Recordation Number as follows, covering the Equipment identified on Exhibit A attached hereto.

i) Lease Supplement No. 1 to Equipment Lease 1999-B between Lessor and Lessee dated as of September 27, 1999, filed with the STB on September 29, 1999 under Rec. No. 22440-B.

Lease Supplement No. 1 was subsequently assigned by Lessor to Bank of America, NA (successor in interest to Lasalle Bank, N.A.) pursuant to Security Agreement -Trust Deed 1999-B Supplement No. 1, dated as of September 27, 1999, duly filed on the date and under the Recordation Number as follows:

i) Supplement No. 1 to Security Agreement-Trust Deed 1999-B between Owner Trustee and Indenture Trustee, dated as of September 27, 1999, filed with the STB on September 29, 1999 under Rec. No. 22440-F.

The Lessor does hereby authorize the filing and recording of this Notice with the United States Surface Transportation Board in order to give effect to the foregoing.
