MEMORANDUM OF TERMINATION OF LEASE

Memorandum of Termination of Lease dated as of October 31, 2012 by Mitsui Rail Capital, LLC (f/k/a MRC Rail Services, LLC), a Delaware limited liability company ("**Lessor**").
