Memorandum of Lease Agreement dated as of November 2, 2012 by Infinity Transportation, LLC, a Delaware limited liability company (the "Lessor").

W I T N E S S E T H:

Lessor (as assignee of The CIT Group/Equipment Financing, Inc.) and Mode Transportation LLC (formerly known as Exel Transportation Services, Inc.) (the "Lessee") are parties to that certain Master Railcar Lease (as may be amended, modified and assigned, the "**Lease Agreement**"), dated as of September 13, 2002, whereby Lessor has agreed to lease to the Lessee and the Lessee has agreed to lease from Lessor certain railroad cars as listed on each Schedule incorporated therein.
