**MEMORANDUM OF LEASE AGREEMENT**

Memorandum of Lease Agreement dated as of November 2, 2012 by Infinity Transportation, LLC, a Delaware limited liability company (the "Lessor").

W I T N E S S E T H:

Lessor (as the assignee of The CIT/Group/Equipment Financing, Inc., as successor to Bombardier Capital Rail Inc., f/k/a NorRail, Inc.) and Lhoist North America of Arizona, Inc. (formerly known as Chemical Lime Company of Arizona) (the "Lessee") are parties to that certain Master Railcar Service and Lease Agreement No. 1839 (as may be amended, modified and assigned, the "**Lease Agreement**"), dated as of April 29, 1999, whereby Lessor has agreed to lease to the Lessee and the Lessee has agreed to lease from Lessor certain railroad cars as listed on each Schedule incorporated therein.
