RELEASE OF INDENTURE

THIS RELEASE OF INDENTURE ("Release") dated as of November 1, 2012 is made by WELLS FARGO BANK, NATIONAL ASSOCIATION (successor to First Union National Bank) (successor to Meridian Trust Company) ("Indenture Trustee").

The Indenture Trustee hereby acknowledges and confirms the following:

A. A Memorandum of Indenture and Security Agreement, dated as of December 1, 1995 (the "Memorandum") between Indenture Trustee and Wells Fargo Bank Northwest, National Association (f/k/a First Security Bank of Utah, National Association) ("Lessor") was recorded at the Surface Transportation Board on December 1, 1995 at 11:30 a.m. under Recordation Number 19377-A for certain equipment described in Schedule 1 attached hereto (the "Equipment"). The Memorandum pertains to that certain Indenture and Security Agreement, dated as of November 15, 1995 (as amended, the "Indenture") between Indenture Trustee and Lessor.

B. The Indenture Trustee does hereby terminate, release and discharge the security interest and the lien of the Indenture held by the Indenture Trustee with respect to the Equipment and accordingly has caused this Release to be executed by its officers thereunto duly authorized, as of the date first above written.
