MEMORANDUM OF ASSIGNMENT OF LEASE

THIS MEMORANDUM OF ASSIGNMENT OF LEASE dated as of this 29th day of November, 2012, is made by GREENBRIER LEASING COMPANY LLC, an Oregon limited liability company, with an address at One Centerpointe Drive, Suite 200, Lake Oswego, OR 97035 ("Transferor"), and GREEN UNION III TRUST, a Delaware statutory trust, with an address at 919 North Market Street, Suite 1600, Wilmington, DE 19801 ("Transferee" and, together with Transferor, the "Parties").

KNOW ALL PERSONS BY THESE PRESENTS THAT:

WHEREAS, Transferor and Transferee have entered into that certain Purchase Agreement (the "Purchase Agreement") dated as of November 29, 2012 relating to the sale by Transferor to Transferee of one hundred (100) covered hopper railcars marked and numbered as set forth in Exhibit A hereto (the "Cars"), and the assignment by Transferor and assumption by Transferee of Transferor's right, title and interest in, and obligations under, Schedule No. 2 dated May 1, 2012 and effective as of April 19, 2012, as amended by Amendment No. 1 to Schedule No. 2 dated September 28, 2012 and effective as of April 19, 2012 (the "Schedule") to the Lease Agreement executed on January 31, 2012 and effective as of November 1, 2011, between Transferor, as Lessor, and FTS International Services, LLC, as Lessee (the "Lease Agreement"), and Transferor's right, title and interest in, and obligations under the Lease Agreement as it relates to the Cars, except as may be expressly otherwise provided in the Purchase Agreement;

WHEREAS, pursuant to the Purchase Agreement and an Assignment and Assumption Agreement of even date therewith (the "Assignment Agreement"), Assignee has acquired all of Assignor's interest in the Cars and Assignor's interest in the Schedule and the Lease Agreement as each relates to the Cars;

WHEREAS, a Memorandum of Lease Agreement with respect to the Lease Agreement and the Schedule (the "Memorandum") was filed with the Surface Transportation Board on May 16, 2012 at 2:51 p.m., and assigned recordation number 30219, and Amendment No. 1 to the Memorandum (the "Memorandum Amendment") was filed with the Surface Transportation Board on October 22, 2012 at 2:50 p.m., and assigned recordation number 30219-A; and

WHEREAS, the Memorandum was filed with the Registrar General of Canada on November 28, 2012 at 3:07 p.m., and the Memorandum Amendment was filed with the Registrar General of Canada on November 28, 2012 at 3:07 p.m.; and

WHEREAS, the Parties wish to show for the public record the existence of the aforesaid assignment by Transferor of its right, title and interest in the Cars, and its right title and interest in and obligations under the Schedule and the Lease Agreement as each relates to the Cars, and accordingly the Parties have caused this Memorandum of Assignment of Lease to be executed by their respective duly authorized officers, as of the date first above written.


