

THIS TERMINATION OF MEMORANDUM OF LEASE is made as of November 28, 2012 by JPMorgan Chase Bank, N.A., formerly Banc One Leasing Corporation (herein "Lessor") and Ag Processing Inc a cooperative (herein "Lessee").


