I am enclosing for recording pursuant to Section 11301 of Title 49 of the United States Code, two executed copies of the Partial Release of Security Interest (Santa Fe Trust No. 1995-1), dated as of December 31, 2012, between Wilmington Trust Company, as owner trustee (the "Owner Trustee"), and The Bank of New York Mellon Trust Company, N.A., as indenture trustee (the "Indenture Trustee"), a secondary document as defined in the Surface Transportation Board's Rules for the Recordation of Documents.

**PARTIAL RELEASE OF SECURITY INTEREST  
SURFACE TRANSPORTATION BOARD  
(SANTA FE TRUST NO. 1995-1)**

THIS PARTIAL RELEASE OF SECURITY INTEREST (SANTA FE TRUST NO. 1995-1) is made and entered into as of December 31, 2012 by and between Wilmington Trust Company, a Delaware trust company, not in its individual capacity, but solely as Owner Trustee ("*Owner Trustee*") under the Amended and Restated Trust Agreement (Santa Fe Trust No. 1995-1) dated as of July 6, 2007 between the Owner Trustee, in its individual capacity and the institution referred to therein as Owner Participant, and The Bank of New York Mellon Trust Company, N.A., a national banking association, as Indenture Trustee ("*Indenture Trustee*").

**WITNESSETH:**

1. The undersigned have entered into that certain Trust Indenture and Security Agreement (Santa Fe Trust No. 1995-1), dated as of July 6, 2007 (the "*Trust Indenture*"), by which the Owner Trustee has granted a security interest to the Indenture Trustee in order to secure the Owner Trustee's performance of certain obligations as described in the Trust Indenture. Capitalized terms used herein without definition have the meanings assigned to them in the Trust Indenture.


2. A memorandum of said Trust Indenture was recorded with the Surface Transportation Board on June 28, 2007 at 9:00 A.M. under recordation number 19518-K pursuant to Section 11301 of Title 49 of the United States Code.

3. The Trust Indenture is hereby terminated effective as of the date hereof with respect to the Unit of railroad equipment set forth on Exhibit A attached hereto which has been deemed to have suffered an Event of Loss.

4. This Partial Release of Security Interest shall neither impair nor terminate the rights and obligations of the parties under the Indenture which expressly survive this partial release.


