TERMINATION OF LEASE (STB)

This Termination of Lease is made and entered into as of November 1, 2012 by and between WELLS FARGO BANK NORTHWEST, NATIONAL ASSOCIATION (f/k/a First Security Bank, National Association), not in its individual capacity, but solely as Owner Trustee, as Lessor ("*Lessor*"), and EXXON MOBIL CORPORATION (successor to EXXON CORPORATION) as Lessee ("*Lessee*").




