TERMINATION AND RELEASE OF LEASE NO. 1000

This Termination and Release (this "*Termination*") of Lease No. 1000 and all amendments thereto (the "*Lease*") is made and entered into as of February 5, 2013, by The Kansas City Southern Railway Company, a Missouri corporation ("*KCSR*"), as successor in interest to Carland, Inc. ("*Carland*"), and as successor in interest to Louisiana & Arkansas Railway Company ("*L&A*").

1. Carland has heretofore leased to KCSR and/or L&A those certain locomotives and railcars set forth in exhibits to the Lease and all amendments thereto, a memorandum or copy of which was duly recorded with the Interstate Commerce Commission on June 4, 1980 at 2:55 P.M. under recordation number 11873. The recordation numbers and dates pertaining to the Lease are listed on Schedule A to this Termination.

2. L&A was merged with and into KCSR on July 6, 1992.

3. Carland was merged with and into Southern Group, Inc. on December 22, 1999.

4. Southern Group was merged with and into KCSR on January 6, 2000, thereby terminating the lease by operation of law on such date with respect to all locomotives and rolling stock leased by KCSR thereunder. Further, the Lease is being terminated with respect to all equipment subject to the Lease as of the date of this Termination.
