NOTICE OF TERMINATION OF LEASE

The undersigned, SIEMENS FINANCIAL SERVICES, INC (successor to First Security Bank, National Association and to Wells Fargo Bank Northwest, National Association), as Lessor (the "Lessor"), for good and valuable consideration, the receipt and sufficiency of which are acknowledged, hereby gives notice that it has terminated the Restated Lease Supplement No. 3A, incorporating by reference all of the terms, conditions and provisions of, the Equipment Leasing Agreement dated as of June 4, 1999 between Lessor, and ALABAMA POWER COMPANY, as Lessee (the "Lessee") (as amended by that certain Amendment No. 1 to Equipment Leasing Agreement, dated as of June 23, 2006, and that certain Amendment No. 2 to Equipment Leasing Agreement dated as of June 23, 2010 and as further amended and supplemented from time to time) (the "Lease") as it affects the railroad equipment described in that Lease (the "Railroad Equipment").

The original Equipment Leasing Agreement was duly filed and recorded with the Interstate Commerce Commission ("Commission") on June 4, 1999 under Recordation Number 22180, as shown in Exhibit A. This document constitutes a termination and release of all interests, claims, liens, or encumbrances over all of the Railroad Equipment.

This Notice of Full Termination of Lease is executed without prejudice to the rights or obligations of the parties which expressly survive under the Lease or the termination agreement between the parties.
