ASSIGNMENT AND ASSUMPTION AGREEMENT**

This Memorandum of Assignment and Assumption Agreement ("Memorandum of Assignment Agreement") made and entered into as of May 24, 2013 by and between **THE DAVID J. JOSEPH COMPANY**, a Delaware Corporation ("Assignor") and **BB&T EQUIPMENT FINANCE CORPORATION**, a North Carolina corporation ("Assignee").

**WITNESSETH:**

1. Assignor has sold, assigned and transferred to Assignee that certain lease agreement dated April 23, 2013 by and between The David J. 


