

NOTICE OF FULL TERMINATION OF LEASE

This Notice of Full Termination of Lease (this "Notice") is made this 13 day of June, 2013, by U.S. BANK NATIONAL ASSOCIATION (successor to The Connecticut National Bank) not in its individual capacity but solely as Owner Trustee, Lessor (the "Lessor") pursuant to that certain Lease Agreement (the "Lease") with Occidental Chemical Corporation, as Lessee (the "Lessee"), dated as of December 14, 1990, as amended and supplemented, (the "Lease").

WHEREAS, the Lease included those certain railcars particularly identified in Exhibit 1 hereto (the "Units");
