This Notice of Lease Termination is effective as of June 18, 2013 by Infinity Asset Opportunity Fund, LLC, a Georgia limited liability company (the "Lessor").

Lessor and Progress Rail Services Corporation a/k/a Progress Rail Services Corporation, Canadian Branch (the "Lessee") were parties to that certain Equipment Lease Agreement, dated as of June 13, 2003, whereby Lessor leased to the Lessee and the Lessee leased from Lessor certain railroad cars pursuant to Schedule No. 1, dated as of June 13, 2003 (as may be amended, modified and assigned, the "Lease").
