

MEMORANDUM OF ASSIGNMENT OF LEASE AGREEMENT

This **MEMORANDUM OF AMENDED & RESTATED ASSIGNMENT OF LEASE AGREEMENT** ("Assignment") is made entered into as of June 1, 2013 by and between The Andersons, Inc. ("Assignor") and Wells Fargo Equipment Finance, Inc. ("Assignee").

WHEREAS, Assignor and Assignee previously entered into a Lease Assignment, Management and Escrow Agreement dated effective as of February 22, 2012,(the "Agreement") which concerned a certain Full Service Lease Agreement, Deal #R01855 between Assignor and Consolidated Grain and Barge Co., a Missouri corporation (the "Lessee"), evidence of which assignment was filed with the Surface Transportation Board under Recordation Number 30105-A on February 24, 2012 .;

WHEREAS, Assignor, Assignee and Lessee have agreed to reduce the number of railcars ("Cars") leased to Lessee under the Lease from one hundred thirty-three (133) Cars to ninety-three (93) Cars effective May 31, 2013 with a copy of the reduced car list attached hereto as Exhibit A;


