

THIS MEMORANDUM OF ASSIGNMENT OF LEASE is made and entered into as of June 28, 2013, by and between BB&T EQUIPMENT FINANCE CORPORATION (the "Assignee") and BANC OF AMERICA LEASING & CAPITAL, LLC (the "Assignor"), with reference to the following:

Assignor, as successor to NationsBank of Texas, National Association the original Lessor, and Port Terminal Railroad Association, as Lessee, have heretofore executed that certain Master Equipment Lease Agreement dated as of January 1, 1996 (together with all amendments thereto), and, pursuant thereto, that certain Lease Supplement and Acceptance Certificate No. 4 dated August 27, 1996 (collectively, the "Lease"), pertaining to the locomotives described therein and further described on Exhibit No. 1 attached hereto (the "Locomotives").

A Memorandum of Lease Agreement was initially filed with the STB on January 14, 1997 under Recordation Number 20486 and was thereafter assigned to the current Assignor by Memoranda of Assignment and Assumption Agreements filed under STB Recordation Numbers 20486-A (April 28, 2004) and 20486-B (May 29, 2012).

Assignor, as assignor, and Assignee, as assignee, have executed that certain Assignment and Specification of Assigned Lease Schedule dated as of the date hereof to that certain Master Assignment Agreement dated as of April 29, 2008 by and between Assignor and Assignee, pursuant to which Assignor has assigned to Assignee all of its rights and obligations under the Lease with respect to the Locomotives.

The parties hereto wish to show for public record this Memorandum of Assignment of Lease to provide notice of such assignment.

This Memorandum of Assignment of Lease may be executed in any number of counterparts, each executed counterpart constituting an original but all together only one Memorandum of Assignment of Lease.


