This **MEMORANDUM OF AMENDMENT NO. 1 TO THE RAILROAD EQUIPMENT LEASE** ("Memorandum of Amendment No. 1") entered into this 24th day of June, 2013, is intended to evidence the amendment dated as of June 24, 2013 (the "Amendment No.1"), between **THE DAVID J. JOSEPH COMPANY**, a Delaware corporation ("Lessor"), and **REFLECTIVE RECYCLING, INC.**, a Texas corporation ("Lessee"), for the purpose of satisfying the requirements of recordation with the Surface Transportation Board under Section 49 of U.S.C. 11301. 
