## MEMORANDUM OF ASSIGNMENT OF LEASE

SURFACE TRANSPORTATION BOARD

This Memorandum of Assignment of Lease between SunTrust Equipment Finance & Leasing Corp., 300 East Joppa Road, 7th Floor, Towson, MD 21286 (the "Assignor"), and The Fifth Third Leasing Company, 38 Fountain Square Plaza, MD 10904A, Cincinnati, OH 42563 (the "Assignee") is effective as of December 29, 2009.

1. This instrument relates to (i) that certain Railcar Lease Agreement dated as of September 23, 2003 (the "Lease Agreement") and the related Equipment Schedule No. 1 (the "Schedule" which term shall also include any and all riders, addenda and exhibits attached to the Schedule, and which together with the Lease Agreement shall collectively be referred to as the "Lease"), between Assignor, as lessor, and Oglethorpe Power Corporation (An Electric Membership Corporation) ("OPC"), as lessee, pursuant to which Assignor leased to OPC 129 Johnstown America Corporation aluminum automatic discharge railcars numbered RWSX 23001-23126 and 23128-23130 inclusive (the Equipment").

2. A Memorandum of Lease Agreement dated as of September 23, 2003 with respect to the Lease Agreement was recorded with the Surface Transportation Board (the "Board") on September 23, 2003 at 1:53 pm under Recordation No. 24600.

3. Pursuant to certain agreements dated as of December 29, 2009, Assignor assigned its interest in the Equipment and the Lease to Assignee. As a result of these assignments, Assignee has acquired all of the rights, title, and interest in and to the Equipment and the Lease of Assignor.

4. The terms and provisions of the Lease and the assignments are more particularly set forth in the Lease Agreement, the Schedule, and the assignment agreements and are incorporated herein by reference.

5. This Memorandum of Assignment of Lease may be executed in any number of counterparts, each executed counterpart constituting an original but all together only one Memorandum of Assignment of Lease.
