**NOTICE OF LEASE CANCELLATION
(EI-Mo III Trust C)**

This Notice of Lease Cancellation (this "Notice") is executed by and between Wilmington Trust Company, not in its individual capacity but solely as Owner Trustee, Lessor, and EI-Mo Leasing III Corporation, as Lessee.

The parties hereto publish this Notice that the Lease of Railroad Equipment, dated September 27, 2000, and the supplements thereto (the "Lease") have been cancelled effective August 11, 2010.

A Memorandum of the Lease was duly filed and recorded with the Surface Transportation Board on September 26, 2000 at 5:23 p.m. under Recordation Number 23119. Supplements were thereafter filed under Recordation Number 23119-B.
