**NOTICE OF PARTIAL TERMINATION OF LEASE**

SURFACE TRANSPORTATION BOARD

The undersigned, BANK OF AMERICA LEASING AND CAPITAL, LLC ("BALCAP"), successor in interest to General Electric Railcar Service Corporation, and LaSalle Bank National Leasing Corporation, Lessor, publishes this notice that the Rider 71 to Car Leasing Agreement, dated as of December 12, 2005, incorporating by reference the terms and conditions of Car Leasing Agreement No. 8812-13, (the "Lease"), between Lessor and Union Pacific Railroad, Lessee, as it applies to those certain covered hopper railcars bearing the reporting marks and road numbers shown on Schedule A attached hereto (the "Terminated Railcars"), is hereby terminated except with respect to those obligations, if any, of Lessor and Lessee under the Lease which expressly survive any termination thereof.

A Memorandum of Lease with respect to the Terminated Railcars was originally filed with the Surface Transportation Board ("STB") on July 7, 2006 at 12:24 p.m. under Recordation Number 26446. A Memorandum of Assignment was originally filed with the STB on September 11, 2006 at 4:52 p.m. under Recordation Number 26446-A. The Memorandum of Lease filed as Recordation Number 26446 incorrectly describes the lease document being terminated as "Rider 73"; the correct reference is "Rider 71".

As of this 15th day of October, 2010, the Lease remains in effect as to the remaining railroad equipment other than the Terminated Railcars.

I certify that I hold the title set forth below, that this instrument was signed on behalf of Lessor by authority of its board of directors and that I acknowledge that the execution of the foregoing instrument was the free act and deed of Lessor. I further declare under penalty of perjury under the laws of the United States of America that the foregoing is true and correct.
