INSTRUMENT OF LEASE TERMINATION (the "INSTRUMENT") is dated as of September 30, 2010, between Banc of America Leasing & Capital, LLC (successor in interest to NationsBanc Leasing Corporation of North Carolina) ("BALC"), as lessor, and GATX/NLC Rail Partners ("GATX/NLC"), as lessee.

WITNESSETH

WHEREAS, a Memorandum of Lease of Railroad Equipment dated as of December 29, 1995 between BALC and GATX/NLC (the "Lease") was recorded at the Interstate Commerce Commission under Recordation Number 19856-A for 150 covered hopper cars numbered GCCX068000-068156 (including seven casualties, the "Railcars"); and

WHEREAS, BALC and GATX/NLC desire to executed this INSTRUMENT to terminate the Lease and to evidence for the public record such termination and satisfaction and release of all the obligations of GATX/NLC and rights of BALC to the Railcars under the Lease, except those obligations and rights that survive termination of the Lease;

NOW, THEREFORE, in consideration of the premises:

BALC and GATX/NLC do hereby terminate the Lease and acknowledge and confirm for the public record such termination and satisfaction and release of all the obligations of GATX/NLC and rights of BALC to the Railcars under the Lease, except those obligations and rights that survive termination of the Lease.




