PARTIAL RELEASE OF SECURITY AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, EOL LEASING, LLC, a Colorado limited liability company, which has an address of 10461 Dowdle Drive, Golden, CO 80403, hereinafter referred to as "Debtor", the Debtor in that certain Security Agreement bearing date the 29th day of September 2009 and recorded October 1, 2009 in the office of the Surface Transportation Board, bearing recordation number 28049, hereinafter referred to as the "Security Agreement", granted and conveyed unto PERFORMANCE FINISHES, INC., a Florida corporation, which has an address of 1737 Lake Terrace Drive, Eustis, Florida 32726, hereinafter referred to as the Creditor, the collateral therein particularly described, to secure payment of the original principal sum of Two Hundred Seventy-One Thousand Nine Hundred Forty-Four and 10/100ths (\$ 271,944.10) Dollars, with interest as therein mentioned;

AND WHEREAS, the said Debtor has requested the said Creditor to release the collateral hereinafter described from the lien and operation of said Security Agreement;

NOW THEREFORE, KNOW YE, that the said Creditor, in consideration of the collateral and of the sum of Ten and No/100ths (\$10.00) Dollars, to it in hand paid by, or on behalf of, the said Debtor at the time of the execution hereof, the receipt whereof is hereby acknowledged, does remise, release, quit-claim, exonerate and discharge from the lien and operation of said Security Agreement unto the said Debtor, its heirs and assigns, that certain portion of the collateral secured by said Security Agreement, more particularly described as follows:

One (1) General Electric Locomotive – loco number 8330

TO HAVE AND TO HOLD the same, with the appurtenances, unto the said Debtor, its heirs and assigns forever, freed, exonerated and discharged of and from the lien of said Security Agreement, and every part thereof; provided always, nevertheless, that nothing herein contained shall in anyway impair, alter or diminish the effect, lien or encumbrance of the aforesaid Security Agreement on the remaining part of said secured collateral, not hereby released therefrom, or any of the rights and remedies of the Creditor thereof.


