LESSOR HEREBY EXPRESSLY DISCLAIMS AND NEGATES ANY IMPLIED OR EXPRESSED REPRESENTATION OR WARRANTY OF ANY AND EVERY KIND, INCLUDING ANY AS TO THE CONDITION, MERCHANTABILITY, OR FITNESS FOR A PARTICULAR PURPOSE, except that there are no Lessor Liens (as such term is defined in Appendix 1 to the Participation Agreement dated as of March 30, 2005, as amended, among the Lessee, the Lessor, The Royal Bank of Scotland N.V. (f/k/a ABN AMRO BANK N.V.), as administrative agent, and the other parties from time to time party thereto).
