

TERMINATION AND RELEASE OF LEASE AGREEMENT SURFACE TRANSPORTATION BOARD

This Termination and Release of Lease Agreement, dated as of December 30, 2010, is made by Deutsche Bank Trust Company Americas ("DBTCA"), as successor in interest to Bankers Trust Company ("Bankers Trust") as Lessor.

WHEREAS, Bankers Trust is the Lessor described in that certain Lease Agreement dated as of June 1, 1971 among Texas, Oklahoma & Eastern Railroad Company ("TOE"), as Lessee, Weyerhaeuser Company ("Weyerhaeuser"), as Guarantor, and Bankers Trust, as Trustee/Lessor, was recorded at the Interstate Commerce Commission ("ICC") on June 23, 1971 at 11:45 am under Recordation No. 6204 for 85 wood chip cars marked and numbered TOE 1250-1334 ("Equipment");


WHEREAS, A Supplement to the Lease dated as of August 25, 1971 among TOE, Weyerhaeuser, and Bankers Trust, was recorded at the ICC on August 26, 1971 at 2:30 pm under Recordation No. 6204-B for 50 wood chip cars marked TO&E 1200-1249 ("Equipment"); and

WHEREAS, A Supplement to the Lease dated as of September 30, 1971, among TOE, Weyerhaeuser, and Bankers Trust, was recorded at the ICC on September 30, 1971 at 10:35 am under Recordation No. 6204-C for 85 wood chip cars marked TO&E 1250-1334.; and


WHEREAS, as of the date hereof, all amounts due under the Lease Agreement have been paid in full

This release and termination shall be subject to and construed in accordance with the laws of the State of New York.




