

TERMINATION OF LEASE AGREEMENT

THIS PARTIAL TERMINATION OF LEASE AGREEMENT ("Termination") is made and entered into as of **MARCH 15, 2011** by between **RARUS RAILWAY COMPANY**, as lessee ("Lessee") and the **FIFTH THIRD BANK**, as lessor ("Lessor"), with reference to the following

1 The Lease Documents **FIFTH THIRD BANK** as lessor and **RARUS RAILWAY COMPANY** as lessee, are parties to that certain Master Equipment Lease dated **MARCH 4, 2010** and Equipment Schedule 001 thereto, dated as of **MARCH 4, 2010** (the "Lease"), a memorandum of which was recorded at the Surface Transportation Board on **MARCH 4, 2010** under Recordation No. **29111**, covering the railcars and equipment described therein.

2 Termination For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged the Lessor has released and discharged, and by these presents hereby terminates said Lease, and the Memorandum of Lease filed under Recordation No **29111**, with respect to one and only one locomotive numbered **RARW 107** described therein and releases and discharges said locomotive from all liens and interest held by the Lessor created or described in said agreement and any renewals or extensions thereof. Notwithstanding the foregoing, the lease remains in force with respect to all other locomotives.

3. Counterparts. This Termination may be executed in any number of counterparts, each of which shall be an original, all of which when taken together shall constitute one agreement binding on all parties, notwithstanding that all parties are not signatories to the same counterpart.
