**MEMORANDUM OF LEASE AGREEMENT****SURFACE TRANSPORTATION BOARD**

Memorandum of Lease Agreement effective as of February 5, 2011 by TLP Rail Trust I, a Delaware statutory trust, as lessor (the "Lessor") and Trinity Industries Leasing Company, a Delaware corporation ("TILC") as manager and agent for the Lessor (in such capacity the "Manager").

**WITNESSETH:**

The Manager, acting for the Lessor as its duly authorized agent, has executed Rider Four (4) to Railroad Car Lease Agreement, effective February 5, 2011 (the "Rider"), pursuant to which the Lessor has agreed to lease to Siouxland Energy & Livestock Cooperative (the "Lessee"), and the Lessee has agreed to lease from the Lessor, certain railroad cars bearing road numbers as listed on Exhibit A hereto.






