

MEMORANDUM OF EXTENSION AGREEMENT

Memorandum of Extension Agreement (this "Memorandum"), made and entered into as of October 1, 2009, by and between **BNY CAPITAL RESOURCES CORPORATION**, a New York corporation ("BNY"), and **BASF CORPORATION**, a Delaware corporation ("BASF").

WITNESSETH

1. BNY (as successor-in-interest to Barclays American/Leasing, Inc.) and BASF (as successor to Badische Corporation) are parties to that certain Lease of Railroad Equipment dated as of August 20, 1984 (the "Lease") relating to certain railcars bearing reporting marks as listed on Annex I attached hereto.
2. A copy of the Lease was filed and recorded with the Surface Transportation Board on September 14, 1984, pursuant to Section 11303 of Title 49 of the United States Code, and was assigned Recordation Number 14425-B.
3. The undersigned have entered into that certain Extension Agreement dated as of September 30, 2004 (the "Extension Agreement"), pursuant to which the original term of the Lease was extended to October 1, 2009 (the Extension Agreement, together with the Lease, the "Extended Lease").
4. The undersigned have entered into that certain Extension Agreement No. 2 dated as of October 1, 2009 (the "Extension Agreement No. 2"), pursuant to which the term of the Extended Lease was further extended to December 31, 2011.
