PARTIAL RELEASE OF SECURITY INTEREST

This Partial Release of Security Interest (this "Partial Release") is by SILVER POINT FINANCE, LLC, as Collateral Agent (in such capacity, the "Collateral Agent"), under that certain First Lien Term Security Agreement, dated as of February 3, 2009 (as amended, supplemented and otherwise modified, the "Security Agreement"), between the Collateral Agent and Hostess Brands, Inc. (formerly known as Interstate Bakeries Corporation), Interstate Brands Corporation and IBC Sales Corporation (and each other Grantor from time to time a party thereto), which was recorded with the Surface Transportation Board on April 15, 2009 at 1:59 p.m. under Recordation Number 27909. Capitalized terms used but not defined herein shall have the meanings ascribed to them in the Security Agreement.

Pursuant to the Security Agreement, the Grantors granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in certain Collateral, including the certain railroad equipment identified on Schedule A attached hereto (the "Released Railcars"). For good and valuable consideration, the receipt and sufficiency of which are acknowledged, the Collateral Agent hereby terminates, releases and discharges its security interest in the Released Railcars.

This Partial Release is executed upon the express conditions that nothing herein contained shall be construed to release the Collateral Agent's security interest in, or impair any lien the Collateral Agent has over any of the Collateral, except for the Released Railcars.
