This Memorandum of a Lease Agreement and Schedule No. 13 thereto is made and entered into as of October 1, 2011 by and between Greenbrier Leasing Company LLC, an Oregon limited liability company ("Lessor") and Wedron Silica Company, an Ohio corporation ("Lessee").

WITNESSETH:

1. Lessor has agreed to furnish to Lessee, and the Lessee has agreed to lease from Lessor one hundred (100) newly built 3,250 cubic foot capacity cement covered hopper railcars with three 30-inch circular loading hatches and two Miner MKE 10513 13-inch by 42-inch low-profile discharge gates, 286,000 lbs. GRL, bearing reporting marks and numbers as listed on Exhibit A hereto.
2. The Lease Agreement shall be effective as of the date first set forth hereinabove and shall be subject to the lease term, as described in the Lease Agreement and Schedule No. 13, as each may be amended from time to time.

IN WITNESS WHEREOF, the parties hereto have caused this instrument to be signed by their respective officers as of the date and year first above written.




