MEMORANDUM OF ASSIGNMENT OF RAILCAR LEASE

11th THIS MEMORANDUM OF ASSIGNMENT OF RAILCAR LEASE dated as of this 11th day of August, 2011, is made by THE CIT GROUP/EQUIPMENT FINANCING, INC., a Delaware corporation, with an address at 30 S. Wacker Drive, Chicago, IL 60606 ("Transferor"), and GATX CORPORATION, a New York corporation, with an address at 222 W. Adams St., Chicago, IL 60606 ("Transferee" and, together with Transferor, the "Parties").

KNOW ALL PERSONS BY THESE PRESENTS THAT:

WHEREAS, Transferor and Transferee entered into that certain Purchase and Sale Agreement (the "Purchase Agreement"), dated as of August 11, 2011, relating to the sale by Transferor to Transferee of 25 carbon black covered hopper railcars identified on Exhibit A hereto (the "Equipment") and the assignment by Transferor and assumption by Transferee of Transferor's right, title and interest in, and obligations under, Lease Schedule No. 01 (the "Schedule"), made as of December 23, 2009, to the Master Net Railcar Lease, dated as of December 23, 2009 ("Master Lease"), which were entered into between Transferor, as lessor, and Orion Engineered Carbons, LLC (f.k.a. Evonik Carbon Black, LLC, f.k.a. Degussa Engineered Carbons, L.P.), as lessee. The Schedule, as it adopts the terms and provisions of the Master Lease, is referred to as the "Lease" herein.

WHEREAS, the Equipment is subject to the Lease;

WHEREAS, a Memorandum of Railcar Lease with respect to Schedule No. 01 and the Master Lease to the extent relating to the Schedule No. 01 was filed with the Surface Transportation Board on August 9, 2010, at 12:56 PM, and assigned recordation number 29397; and

WHEREAS, the Parties wish to show for the public record the existence of the aforesaid assignment by Transferor of its right, title and interest in, and obligations under, the Lease to Transferee, and accordingly the Parties have caused this Memorandum to be executed by their respective duly authorized officers, as of the date first above written.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged by each of the Parties hereto, by this instrument Transferor hereby confirms the sale of the Equipment to Transferee and the assignment to Transferee of Transferor's right, title and interest in, and obligations under, the Lease in accordance with the terms and conditions of the Purchase Agreement, and Transferee confirms and accepts such terms and conditions, which are incorporated by reference as if fully set forth herein.


