

THIS FULL RELEASE OF MEMORANDUM OF COMMERCIAL SECURITY AGREEMENT AND MEMORANDUM OF (COLLATERAL) ASSIGNMENT OF LEASE (this "Release") is dated as of this 1st day of March, 2012, by The Bank of Edwardsville, an Illinois corporation (the "Secured Party"), witnesseth:

WHEREAS, the Secured Party and Midwest Railcar Corporation, an Illinois corporation ("Midwest") entered in that certain Memorandum of Commercial Security Agreement and that certain Memorandum of (Collateral) Assignment of Lease, each dated as of March 10, 2004 and recorded with the Surface Transportation Board under recordation numbers 24859-A and 24859-B, pursuant to which Midwest granted the Secured Party a security interest in Seventeen (17) 4400 c.f., 100-ton gondola railcars identified by the reporting marks MWCX 100426-100442, inclusive, more specifically described on Schedule I attached hereto (collectively, the "Equipment") and assigned to the Secured Party, as collateral, its rights, title and interest in and to that certain Memorandum of Rider #4 dated as of March 3, 2004, recorded with the Surface Transportation Board under recordation number 24859 by and between Midwest, as lessor, and OmniSource Corporation, an Indiana corporation, as lessee (the "Lease").

WHEREAS, the Secured Party desires to release the lien against the Equipment and the Lease, as it relates to the Equipment, created or arising out of the Memoranda.

NOW, THEREFORE, in consideration of the premises contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party submits the following:

1. The Secured Party releases the lien against the Equipment and the Lease, as it relates to the Equipment, created or arising out of the Memoranda.
2. This Release shall be recorded with the Surface Transportation Board so as to record the release of the lien against the Equipment and the Lease, as it relates to the Equipment, constituted by the Memoranda.
3. This Release does not affect the Secured Party's lien created or arising out of the Memoranda as it relates to railcars listed therein other than the Equipment.


