

MEMORANDUM OF ASSIGNMENT OF LEASE

THIS MEMORANDUM OF ASSIGNMENT OF LEASE dated as of this 21st day of June, 2012, is made by BANK OF AMERICA, N.A. (the "Assignor"), and REGIONS COMMERCIAL EQUIPMENT FINANCE, LLC, (the "Assignee" and, together with the Assignor, the "Parties").

KNOW ALL PERSONS BY THESE PRESENTS THAT:

WHEREAS, Assignor, as successor in interest to Banc of America Leasing & Capital, LLC, and Assignee entered into that certain Assignment and Specification of Assigned Lease Schedule (the "Assignment") dated as of June 21, 2012 relating to the sale by Assignor to Assignee of 337 railcars identified on Schedule 1 (the "Equipment") and the assignment by Assignor and assumption by Assignee of Assignor's right, title and interest in, and obligations under, the Master Lease Agreement, dated as of May 2, 2006, between Westar Energy, Inc. ("Westar"), as lessee, and Assignor, as lessor (the "Lease Agreement"), and three schedules thereto, specifically Schedule No. 16426-11500-001 dated May 2, 2006, Schedule No. 16426-11500-002 dated May 8, 2006, and Schedule No. 16426-11500-003 dated August 15, 2006 (each a "Schedule" and collectively the "Schedules"), between Assignor, as lessor, and Westar, as lessee. The Schedules and the Lease Agreement, as it relates to the Schedules, are collectively referred to as the "Lease".

WHEREAS, the Equipment is subject to the Lease.

WHEREAS, a Memorandum of Master Equipment Lease Agreement with respect to Schedule No. 16426-11500-001 was filed with the Surface Transportation Board on May 4, 2006 and assigned recordation number 26323.

WHEREAS, a Memorandum of Master Equipment Lease Agreement with respect to Schedule No. 16426-11500-002 was filed with the Surface Transportation Board on May 11, 2006 and assigned recordation number 26323-A.

WHEREAS, a Memorandum of Master Equipment Lease Agreement with respect to Schedule No. 16426-11500-003 was filed with the Surface Transportation Board on August 16, 2006 and assigned recordation number 26512.

WHEREAS, the Parties wish to show for the public record the existence of the aforesaid assignment by Assignor of its right, title and interest in, and obligations under, the Lease to Assignee, and accordingly the Parties have caused this Memorandum to be executed by their respective duly authorized officers, as of the date first above written.

NOW, THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged by each of the Parties hereto, by this instrument the Assignor hereby confirms the sale of the Equipment to Assignee and the assignment to Assignee of Assignor's right, title and interest in, and obligations under, the Lease in accordance with the terms and conditions of the Assignment, and the Assignee confirms and accepts such terms and conditions, which are incorporated by reference as if fully set forth herein.
