MEMORANDUM OF ASSIGNMENT OF LEASE AGREEMENT

This **MEMORANDUM OF ASSIGNMENT OF LEASE AGREEMENT** (“Assignment”) is made entered into as of August 17, 2012 by and between The Andersons, Inc. (“Assignor”) and First Financial Bank Equipment Finance, LLC (“Assignee”).

WHEREAS, The Connecticut Bank and Trust Company acting solely in its capacity as Trustee under a Trust Agreement with Security Pacific Equipment Leasing, Inc., as Lessor, and Dow Chemical Company (“Lessee”), entered into a certain Lease of Railroad Equipment dated May 15, 1978 (the “Master Lease”), and Assignor and Lessee entered in to a Lease of Railroad Equipment Rider, Deal #R01936 effective April 1, 2012 (collectively with Master Lease, the “Lease”), evidence of which is recorded with the Surface Transportation Board (“STB”) pursuant to 49 U.S.C. §11301, at recordation number 30343;


