

NOTICE OF TERMINATION OF LEASE

THIS NOTICE OF TERMINATION OF LEASE (this "Notice") is made this 29th day of August, 2012, by MIDWEST RAILCAR CORPORATION, successor-in-interest to Macquarie Rail Inc. ("Lessor") with respect to that certain Rider No. 1 dated as of April 6, 2010 ("Rider 1") to that certain Railcar Leasing Agreement (Full Service) (Lease #1017-101) dated as of March 31, 2010 ("Master Lease"), each by and between Lessor, as lessor, and Frac Tech Services, LLC, as lessee ("Lessee") (Rider 1 and Master Lease, solely to the extent it relates to Rider 1, are collectively referred to herein as the "Lease"), pursuant to which Lessor leased to Lessee certain railcars more particularly identified in Exhibit I hereto (the "Railcars").

WHEREAS, a Memorandum of Lease and a Supplement to Memorandum of Lease, each by and between Lessor, as lessor, and Lessee, as lessee, and each dated as of April 6, 2010, evidencing the existence of the Lease were duly recorded with the Surface Transportation Board on May 5, 2010 under Recordation Numbers 29248 and 29248-A, respectively.

WHEREAS, the Lease has been terminated with respect to all Railcars.

NOW THEREFORE, Lessor wishes to show for the public record the fact of such termination of the Lease with respect to all Railcars.

This Notice will be recorded with the Surface Transportation Board so as to evidence the termination of the Lease with respect to all Railcars.
