

**MEMORANDUM OF EQUIPMENT LEASE AGREEMENT
(GATX TRUST NO. 2012-1A)**

THIS MEMORANDUM OF EQUIPMENT LEASE AGREEMENT (GATX TRUST NO. 2012-1A) made and entered into on September 28, 2012 (this "**Memorandum**") between **U.S. BANK NATIONAL ASSOCIATION**, not in its individual capacity but solely as Owner Trustee under the Trust Agreement, as Lessor ("**Lessor**") and **GATX CORPORATION**, a New York corporation, as Lessee ("**Lessee**").

WITNESSETH:

The undersigned have entered into that certain Equipment Lease Agreement (GATX Trust No. 2012-1A) (the "**Lease Agreement**"), dated as of September 28, 2012, whereby the Lessor has agreed to lease to the Lessee and the Lessee has agreed to lease from the Lessor assorted railroad cars (collectively, "**Equipment**"), described in the Memorandum of Lease Supplement No. 1 to Equipment Lease Agreement (GATX Trust No. 2012-1A), dated as of September 28, 2012 which is being filed with the Surface Transportation Board concurrently herewith.

For the purposes of facilitating the execution of this Memorandum, this Memorandum may be executed simultaneously in any number of counterparts, each of which counterparts shall be deemed to be an original, and all of which counterparts shall constitute but one and the same instrument.

Capitalized terms used herein and not otherwise defined shall have the meanings assigned thereto in Appendix A to the Lease Agreement.
