**MEMORANDUM OF SUPPLEMENT NO. 1
TO EQUIPMENT LEASE AGREEMENT
(GATX TRUST NO. 2012-1D)**

THIS MEMORANDUM OF LEASE SUPPLEMENT NO. 1 TO EQUIPMENT LEASE AGREEMENT (GATX TRUST NO. 2012-1D) dated as of September 28, 2012 (this "Memorandum") is by and between **U.S. BANK NATIONAL ASSOCIATION**, not in its individual capacity but solely as Owner Trustee under the Trust Agreement, as Lessor ("Lessor"), and **GATX CORPORATION**, a New York corporation, as Lessee ("Lessee").

W I T N E S S E T H:

The Lessor and the Lessee have entered into that certain Equipment Lease Agreement (GATX Trust No. 2012-1D), dated as of September 28, 2012 (the "Lease Agreement"), a memorandum of which is being filed with the Surface Transportation Board concurrently herewith.

The Lessor and the Lessee have entered into that certain Lease Supplement No. 1 to Equipment Lease Agreement (GATX Trust No. 2012-1D), dated as of September 28, 2012, whereby certain railroad cars (collectively, the "Equipment"), which are set forth in Exhibit A, attached hereto, are made subject to the Lease Agreement.
