MEMORANDUM OF TERMINATION OF LEASE

Memorandum of Termination of Lease dated as of October 31, 2012 by Mitsui Rail Capital, LLC (f/k/a MRC Rail Services, LLC), a Delaware limited liability company ("*Lessor*").

WITNESSETH:

1. Lessor and CSX Transportation, Inc. (the "*Lessee*") are parties to that certain Master Car Lease Agreement (the "*Lease Agreement*"), dated April 20, 2000, and Schedule No. 2 thereto dated as of April 20, 2000 (the "*Schedule*"), whereby Lessor leased to the Lessee and the Lessee leased from Lessor certain railroad cars described in such Schedule. (The Schedule, incorporating the terms of the Lease Agreement, is herein referred to as the "*Lease.*")
