

This **MEMORANDUM OF RIDER NO. 1 TO THE MASTER LEASE AGREEMENT** ("Memorandum of Lease") entered into this 9<sup>th</sup> day of October, 2012, is intended to evidence the master lease agreement dated as of March 30, 2012, as amended by agreement dated October 9, 2012, and subsequent rider number 1 to the master lease agreement originally dated March 30, 2012 as amended by agreement dated September 11, 2012 (collectively, the "Lease"), between **THE DAVID J.
