

**NOTICE OF
LEASE TERMINATION**

This Notice of Lease Termination is effective as of November 5, 2012 by Infinity Transportation, LLC, a Delaware limited liability company (the "Lessor").

W I T N E S S E T H:

Lessor (as the assignee of The CIT/Group/Equipment Financing, Inc., as successor to Bombardier Capital Rail Inc.) and Norfolk Southern Railway Company (the "Lessee") are parties to that certain Railcar Service and Lease Agreement No. 0351793, dated May 6, 1998, whereby Lessor leased to the Lessee and the Lessee leased from Lessor certain railroad cars pursuant to Schedule No. 007 to Railcar Service and Lease Agreement No. 0351793 (as may be amended, modified and assigned, the "Lease").
