

NOTICE OF PARTIAL TERMINATION

THIS NOTICE OF PARTIAL TERMINATION (this "Notice") is made this 26 day of September, 2012, by RELCO FINANCE, INC. ("Relco"), as assignee of The David J. Joseph Company ("DJJ"), pursuant to that certain Memorandum of Assignment and Assumption Agreement, dated as of June 3, 2004 (the "Memorandum"), between Relco, as assignee, and DJJ, as assignor.

WHEREAS, the Memorandum was duly recorded with the Surface Transportation Board on June 22, 2004 under Recordation Number 24997-A for certain locomotives, including those certain locomotives particularly identified in Exhibit 1 hereto (the "Units");

WHEREAS, Relco wishes to terminate the Memorandum solely with respect to the Units and to show for the public record the fact of this partial termination; and

WHEREAS, DJJ has notified Relco that it consents (i) to the partial termination by Relco, unilaterally, of the Memorandum with respect to the Units and (ii) that the fact of such partial termination should be shown for the public record by Relco, unilaterally;

NOW THEREFORE, Relco hereby terminates the Memorandum solely with respect to the Units, and this Notice will be recorded with the Surface Transportation Board so as to evidence the partial termination of the Memorandum with respect to the Units.


