

**SURFACE TRANSPORTATION BOARD**

This Assignment of Loan & Security Agreement (this "Assignment") is being executed and delivered by FIFTH THIRD BANK ("Assignor") to IOWA PACIFIC HOLDINGS, LLC, an Illinois limited liability company ("Assignee").

WHEREAS, Assignor and Assignee have entered into a certain Loan Purchase and Assumption Agreement by and between Assignor, as Seller, and Assignee, as Buyer, dated as of October 12, 2012 (the "Agreement") whereby Assignee has agreed to purchase certain loans of Titan Transit, Inc., Titan Rail, Inc. and Titan Leasing, Inc. from Assignor and Assignor has agreed sell, assign, transfer and convey such loans to Assignee.

EXPRESSLY SUBJECT, IN ALL RESPECTS, TO THE TERMS AND PROVISIONS OF THE AGREEMENT, WHICH ARE INCORPORATED HEREIN BY THIS REFERENCE.

This Assignment shall be governed by, and construed in accordance with, the laws of the State of Ohio.


