

This MEMORANDUM OF LEASE is made and entered into as of October 24, 2012, between PNC Equipment Finance, LLC, a Delaware limited liability company ("**Lessor**"), and Olin Corporation, a Virginia corporation, by and through its Chlor Alkali Products division and for and on behalf of itself and its subsidiaries which may perform hereunder ("**Lessee**"), with reference to the following:

1. 
2. The Lease shall be effective as of the date hereof and shall be subject to the term specified in the Lease, and any extension of such term to the extent provided for in the Lease.


