

**WITNESSETH**


This Memorandum of Lease is entered into as of the 21 day of November, 2012, by and between The Andersons, Inc., an Ohio corporation, having its principal place of business at 480 W. Dussel Drive, Maumee, OH 43537 (hereinafter "Lessee") and PNC Equipment Finance, LLC, a Delaware limited liability company, having its principal place of business at 995 Dalton Avenue, Cincinnati, Ohio 45203 (hereinafter "Lessor").

1.
