MEMORANDUM OF LEASE

SCHEDULE NO. 2

This is a Memorandum of Schedule No. 2, executed on Nov. 14, 2012 and effective as of October 1, 2012, to a Lease Agreement made and entered into as of October 1, 2012, by and between Greenbrier Leasing Company LLC, an Oregon limited liability company, ("Lessor") and J.P. Morgan Commodities Canada Corporation, a Canadian corporation ("Lessee").


