**PARTIAL TERMINATION OF LEASE AGREEMENT
SURFACE TRANSPORTATION BOARD
(SANTA FE TRUST NO. 1995-1)**

THIS PARTIAL TERMINATION OF LEASE AGREEMENT (SANTA FE TRUST NO. 1995-1) is made and entered into as of December 31, 2012 by and between Wilmington Trust Company, a Delaware trust company, not in its individual capacity, but solely as Owner Trustee, as Lessor ("*Lessor*"), and BNSF Railway Company (successor to The Atchison, Topeka and Santa Fe Railway Company), a Delaware corporation, as Lessee ("*Lessee*").

WITNESSETH:

1. The undersigned have entered into an Equipment Lease Agreement (Santa Fe Trust No. 1995-1), dated as of June 27, 1995 (as amended, supplemented or modified, the "*Lease*"), whereby the Lessor has agreed to lease to Lessee and Lessee has agreed to lease from the Lessor certain railroad equipment. Capitalized terms used herein without definition have the meanings assigned to them in the Lease.



The Lease (or a memorandum thereof) was recorded with the Interstate Commerce Commission (as predecessor to the Surface Transportation Board) on July 7, 1995 at 11:30 A.M. under recordation number 19518 pursuant to Section 11303 of Title 49 of the United States Code (now known as Section 11301 of Title 49 of the United States Code).

3. The Lease is hereby terminated effective as of the date hereof with respect to the Unit of Equipment set forth on Exhibit A attached hereto which has been deemed to have suffered an Event of Loss.

4. This Partial Termination of Lease Agreement shall neither impair nor terminate the rights and obligations of the parties under the Lease which expressly survive this partial termination.






